Ld. counsel for MCD has strongly opposed the He submits that the order dated application. 06.11.2024 clearly records the submissions made by Ld. counsel for the appellant that they have filed the present appeal only in respect of first floor of the property in question. He submits that the said fact is also stated in para 8 (H) of the appeal. submits that appellant has placed on record copy of sale deed dated 09.02.2023 and 20.07.2023 which shows that appellant has bought portions on the Eastern side and Western side of the first floor with roof/terrace rights up to sky. He submits that from a bare perusal of the sale deed it is clear that in the year 2023 there was no structure over and above the first floor of the property in question. He submits that by present application appellant is making a misadventure to extend the scope of the interim protection to the second floor to fifth floor of the He submits that despite property in question. opportunity given by the Tribunal the appellant has failed to place on record any document to show that the structure from second floor to fifth floor is an old structure.

- 6. I have heard the arguments and perused the record. Before proceeding further to decide this application the Tribunal deprecates the conduct of Ld. counsel for the appellant who despite seeking a pass over in the morning failed to appear before the Tribunal despite various calls.
- 7. In the application appellant is seeking amendment that in para 8 (H) of the appeal it is inadvertently written that the appellant is the owner of first floor of the property. It is argued that appellant is owner of first floor and above and the structure above the first floor also needs to be protected in terms of the interim order dated 06.11.2024.
- 8. Perusal of order dated 06.11.2024 shows that Ld. counsel for the appellant made a clear submission that they have filed the present appeal only for the first floor of the property in question. Para 8 (H) of the appeal also mentions that appellant filed this appeal for first floor of the property in question. Both the sale deeds of the year 2023 also shows that the only structure which existed in the Eastern side and western side of the property is first floor only. Appellant has failed to place on record any other documents to show the existence of second floor to fifth floor of the property prior to the cutoff date.
- I found merits in the submissions made by Ld. counsel for MCD that present application is nothing but a misadventure to mischievously seek protection in respect

of the second floor to fifth floor in terms of order dated 06.11.2024. From the sale deeds of the appellant it is clear that no structure above first floor existed in the year 2023 therefore, the question of grant of interim protection to the structure above first floor does not arise at this juncture.

10.1 do not found any merits in the application and the same is dismissed with a cost of Rs.10,000/- to be deposited with the Registry of this Tribunal.
