1. The present appeal is filed by appellant impugning the sealing order. Appellant is stated to be the owner of property in question in which the respondent no. 2 Punjab & Sind Bank is carrying out the banking activity.
2. Ld. counsel for MCD submits that they have issued a show cause notice dated 09.06.2025 under Section 345A of DMC Act and the adjudication is still under process. He submits that MCD yet to pass order under Section 345A of DMC Act.
3. An application under Order 1 Rule 10 CPC is filed by residents / complaints for their impleadment in this case. Ld. counsel for intervener submits that size / area of plot is less than 200 sq. mtrs and as per MPD - 2021 banking

activities are not permitted in properties wherein plot area is less than 200 sq, mtrs. He submits that due to banking activities, the residents of area are facing parking constraints and due to heavy footfall the area has become very busy and causing problems to pedestrians. He submits that MCD is unnecessarily delaying the proceedings and causing inconvenience to the public at large.

4. Ld. counsel for appellant as well as respondent no.2 i.e. Punjab & Sind Bank also submits that due to delay in adjudication by MCD the fate of banking activities is at stake and adjudication in present case needs to be expedited by MCD.
5. Ld. counsel for respondent / MCD on instructions submits that they have already conducted hearings in the matter and will decide the matter on top priority within seven working days from today.
6. Appellant submits that in view of the submissions made by MCD, he has no issue in withdrawing the present appeal at this juncture with the liberty to file fresh appeal as and when fresh cause of action arises. Separate statement of appellant is recorded in this regard.
